

Letter from the President

Dear Siblings in Christ,

As the year draws to a close, I am naturally drawn into a period of reflection about all that has happened at Good Shepherd in the last year. As part of this reflection, I recall Pastor Peterson's first sermon to the newly formed Good Shepherd congregation in 1956 and his message of "For A Better Tomorrow." As I think about our successes over the last year, I firmly believe we are delivering on this message of "For A Better Tomorrow" as we continue to:

- Welcome as we have been Welcomed,
- Forgive as we have been Forgiven,
- Serve as we have been Served.

Reflecting back on the year that was, there were four areas of focus that garnered much of the Board of Directors' time. They include:

- **Strategic Plan Implementation**
- **Dreaming Beyond**
- **Verona Campus Entrance**
- **Facility Investments**

Recall that at last year's Annual Meeting, the new **Strategic Plan** was unveiled. Over the course of the last year, the six pillars have been working diligently to implement the various components of this plan. While each of the pillars is at different stages of implementation, progress is being and will continue to be made in building "For A Better Tomorrow." **Thanks be to God!**

Following the three-year **Beyond** campaign that concluded at the end of 2022, the decision was made to initiate another capital campaign, **Dreaming Beyond**, to continue on our journey of mortgage debt elimination. This 18-month campaign, led by Tom and Karen Golden, resulted in \$817,000 of pledges. As a result of these two campaigns and your tremendous generosity, the mortgage balance now stands at \$690,000, which is down from \$1,306,000 a year ago, and \$3,130,000 at the end of 2019. **Thanks be to God!**

Last Summer, we were informed by the City of Verona that our **Verona Campus Entrance** for westbound traffic was untenable due to safety concerns related to the volume of traffic at Epic. As a result, the Board had to make a series of decisions in a relatively short time frame to create a new entrance. Many thanks to Steve Frei for shepherding the board through this arduous process as he worked with the various stakeholders to create an outcome that was satisfactory to all. In addition, there were two generous donors who funded the beautiful digital sign that is at this new entrance, which is welcoming to our neighbors at Epic. **Thanks be to God!**

Lastly, as a result of being in a solid financial position, we were able to make some significant **Facility Investments**, which was highlighted by new roofs at both locations. **Thanks be to God!**

The successes I have highlighted in this letter aren't intended to be all encompassing, but rather a subset of Good Shepherd's hard work over the last year. I want to thank Pastors, staff and members of the congregation for making all of this possible. I look forward to working with all of you in the upcoming year as we continue to deliver on "For a Better Tomorrow."

Lawrence Freedman, in his massive and fascinating tome, Strategy: A History, writes, "Without some prior deliberation it might be even harder to cope with the unexpected, pick up the cues of a changing situation, challenge set assumptions, or consider the implications of uncharacteristic behavior... Adding flexibility and imagination... offers a better chance of keeping pace with a developing situation, regularly re-evaluating risks and opportunities."

This past year, Good Shepherd's leadership, staff, volunteers and members have continued to live out our mission to Welcome as we have been welcomed, Forgive as we have been forgiven, and Serve as we have been served. Our Strategic Planning Committee, chaired by Steve Frei and vice-chaired by Brenda Wilcox, presented our new strategic plan to the church at our last annual meeting. The past twelve months have been spent in the implementation of the plan across six "pillar" groups and 10+ committees. There have been two leadership summits and multiple discussions and actions. You can see the fruits of these actions in these pages. You can also see it in hundreds of other efforts, both visible and behind-the-scenes, that have brought this church through the disruptions of the pandemic to a new period of growth. There's also excitement about what lies ahead in the changing landscape of being a church community in the present age.

While launching a strategic plan and emerging from a pandemic, Good Shepherd also initiated the Dreaming Beyond debt reduction campaign, working with a phenomenal leadership cabinet chaired by Tom and Karen Golden, along with the Generosity Committee. Our second all-campus worship event at Verona Area High School was an opportunity to see each other again while celebrating the amazing "Good Shepherd" worship experience. Bringing our mortgage total to under \$700,000 at of July 1 is just icing on the cake. Thank you for your generosity and prayerful support of both our operating budget and the capital campaign.

Our strategy gave us the confidence to make some key staffing moves in Outreach with Rick Thomas and Pr. Dara Schuller-Hanson stepping into new roles. We welcomed Pastor Joe Brosious back officially as our Pastor of Engagement, a role that will allows him to use his gifts of meeting people where they are at while he continues his healing journey. We said farewell and gave thanks for the ministry of Becca Feldhacker to our youth and their families. Becca's four years of humble leadership and service through unprecedented upheaval in the lives of our young people kept our foundation strong and gives our church a good idea of the qualities and spiritual maturity that will be needed in her successor. I invite your prayers for the Children, Youth and Family Committee as they do the hard, deep work of praying and developing a job description for this key role. I am also grateful for Sarah Iverson for offering to move back to full-time interim Director of Youth and Family so that we keep our positive momentum in a time of change.

These are just a few of the many people and events that make up our life together as a church. I know there are multiple other examples any one of you reading this can list of how a staff person, pastor or fellow member has been an example of holy hospitality, grace and service.

I am and remain grateful for the dedication, generosity in time, talents and treasure, and humble service of everyone who calls this church their home.

Pastor of Congregational Care Sheryl Erickson

Thank you, Good Shepherd, for the continued honor to walk with you, as one of your pastors, through life in our Christian community of faith! As Pastor of Congregational Care, here are some highlights of ministry areas where I both lead and serve alongside you:

Funeral/Memorial Services - In our congregation, we take time to not only plan meaningful Christian services at the time of someone's death, but we minister to grieving families before and after their loss. Being present to offer Christian care immediately following a loved one's death, planning a service, tending to all the details of each loss with compassion, and then officiating the actual service, is a ministry I deeply feel called to by God. I am, more regularly, the pastor officiating these services. So far, in 2023 we've held nearly as many funeral/memorial services as we held in all of 2022. In 2023, our congregation has hosted 10 funeral/memorial services with three graveside services. In 2022, we hosted a total of 15 funeral/memorial services with two graveside services.

Grief Packet Ministry – I continue to work with Jessica McCarty in our grief packet ministry of sending 4 mailings a year to individuals in our congregation who have lost a loved one in death. We have 41 active packets as of this report.

Grief Group Support Sessions – I have offered these support sessions once a year in the last several years, with Pr. Mark Renner and I co-coordinating these sessions.

Pastoral Care – With hospitals opening back up to in-person visits, we're now averaging more than five in-person pastor visits a month. I expect this number of in-person visits to increase as the year goes on. Our other forms of pastoral care remain consistent, with follow-up phone calls and emails averaging 45 calls a month.

Internal Pillar Meetings: Membership and Belonging – I'm working with a small group, led by Brenda Wilcox, to implement this portion of our Strategic Plan. We've met at least monthly to explore opportunities to expand our sense of belonging and community as God's people who gather inside and outside the walls of our church.

Inreach Ministries – It is my deep pleasure to serve as the staff member partnering with our congregation's Inreach Committee. Please see their report elsewhere in this booklet, thanks to our chair, Cathy Peercy.

Stephen Ministry – Recruiting is underway for a new Stephen Ministry class. Stephen Ministry training requires a 50-hour commitment, so I'm not sure if we'll have enough interest to offer a class in the fall, but we're doing our best to get the word out. Our current team of 13 Stephen Ministers meets monthly for supervision and at times, continuing education. These people are ready, at any time, to care one on one for people going through a life difficulty.

Baptism Classes – What a joy to meet new babies, children and their parents as they prepare for this sacrament! I get the pleasure of teaching this class and having the assistance of Emily Gold. Then you all share in that joy with me whenever we celebrate the sacrament of baptism at a worship service! You know we've been blessed to baptize many people in the last year and a half!

This snapshot of a report contains metrics. Please remember that metrics represent lives touched by the loving care of Jesus Christ and stirred by the Holy Spirit, thanks to all of us in partnership with the gospel, through Good Shepherd Lutheran Church. Thanks be to God!

It continues to be a great joy to serve Good Shepherd in a variety of ways. This year I have been able to be a part of so many different ministries and learned that while we all have different gifts, we are coworkers united in Christ. The words of 1 Corinthians have been a beautiful theme as I serve this community. This year has brought changes to my role at Good Shepherd as I take on the new title of Pastor of Community Partnerships. I will continue to work in the areas of welcome and outreach, alongside Rick Thomas, as we work to grow our partnerships with organizations and other faith communities. When Christians work together in the name of Christ, there is so much we can do, especially as we honor one another's gifts. That is what I hope to do in this new role.

This past year I have helped lead our Holy COW food truck ministry, led the food pantry garden team and gotten more involved in our Social Action committee, alongside my other duties of preaching, teaching Amped and officiating at weddings, pastoral care and funerals. It has been a full year as our congregation rolled out our strategic plan and continued to grow into our understanding of what it means to be a congregation that welcomes, forgives and serves. I am a part of both the Welcome Pillar and the External Pillars as we dream about new ways to be the church to our community.

A big change for me this year began in January 2023 when I started a Doctor of Ministry program at the University of Dubuque Theological Seminary. I will complete three years of coursework, while continuing to work full time at Good Shepherd. Then I will do a thesis project or paper in the fourth year. I have been reading a lot as a part of my course and am enjoying diving into new theological learnings as a part of my cohort. I have a Congregational Resource Team of Good Shepherd members that will help support and pray for me as I move along in this program. A Doctor of Ministry degree is meant to benefit both the pastoral leader and the congregation. My hope is that this will be a blessing to Good Shepherd too. Thanks for supporting me in taking this on!

Objective: For Lutherans, worship stands at the center of our life of faith. The Worship, Music and Arts Committee is responsible for cultivating a unified, innovative and engaging multi-generational music and arts program that enhances our worship life while connecting our members and community.

Throughout the past year, the Worship, Music and Arts Committee has remained strong and diligent through another year of being church together – meeting people where they are at – by worshipping together within our buildings and from afar online. For the first time in three years, we are finally starting to feel a sense of “normalcy” since the pandemic. Our music groups are in full force rehearsing and enhancing our worship regularly, we’ve evolved our communion practices from prepacked cups to wine chalices and wafer, re-engaged and strengthened our volunteer teams, and offered additional worship opportunities especially during Advent and Lent – while embracing the beauty and distinctions among our three diverse weekly worship services.

A significant highlight this year was hiring Matt Skibo as our Music Coordinator. Matt has been a wonderful addition to our community and ministry. He has energetically led Church School music, middle school Amped music, and has reengaged our children’s music programming, while also providing administrative support to Jared, our Director of Worship and Music. We’re lucky to have Matt on our worship and music team. We appreciate and are blessed by his talents and authentic spirit.

Our summer once again featured fun, intergenerational community gatherings. Worship in the Park gathered weekly around both campuses in Fitchburg and Verona. We heard stories from mission partners and Madison area pastors about how food and faith intersect in their lives and ministries. Music Mondays continued to flourish, featuring talented musicians and friends from Good Shepherd and the Madison area. The 2022 year featured two new music additions, the UW Madison Marching Band and “All that Jazz” Big Band, all paired with delicious food served from the Holy COW. These free concert gatherings are made possible through the Good Shepherd Foundation. Both exciting summer opportunities provided great times of fellowship, conversation and community presence.

As we lean into the months ahead, we look forward to our cooperative work with the Strategic Plan Worship Pillar and partnerships with other committees to further enhance our worship and congregational life together.

“I participate in the Card Ministry because it matters to me that people know they are not forgotten and that someone from the congregation is thinking of them. This is particularly true for members such as homebound people, kids away at college, or people celebrating milestone anniversaries to let them know that we are thinking about them and wishing them well.” Susie Cramer, Card Ministry Team Leader

The Card Ministry (Susie Cramer, Ruth Paulson) is a prime example of how programs within Inreach’s purview spread across the entire life of the GS community. Kimberly King’s Keeping the Connection team sends cards and care packages to our young people in college. Cards are made available in the Food Pantry so our clients can have a card for their special events. Staff, committees and program leaders send sympathy, get well, thinking of you and thank you cards among the many created by the Card Ministry team. They have made **1,886** cards since January 2022.

Inreach teams with Hospitality to give support to Pr. Dara and Pr. Sheryl by being present at new member gatherings and making follow-up phone calls to those who have joined GS and those who have not. Inreach also teams with Hospitality for Name Tag Sundays which give people in the pews the ability to call their neighbor by name.

Shepherd’s Hands (Barb Friberg, Pat Westimayer, Kathie Schroedel) continue to make hats, scarves and mittens for our Outreach programs such as the Food Pantry. They also have made baptismal blankets for our new brothers and sisters in Christ and prayer shawls for those who have health issues or are facing an end-of-life diagnosis.

Home Communion (Jessica McCarty) and Altar Flower Delivery teams (Pr. Sheryl, Judy Hoard) bring friendly conversation, the Eucharist and beautiful bouquets to people where they are – in their homes. Vicky Ruff’s Prayer Chain team adds requested prayers to their own prayer schedules to give emotional and spiritual help to congregants. A series of Grief Packets (Jessica McCarty) are mailed to those who have lost a loved one. Stephen Ministers (Pr. Sheryl, Karna Boquet, Marilyn Sharrow, Jennifer Fagan) provide Christian care to those who face struggles, difficult situations in their lives. PrimeTimers events (Sarah Iverson) keep the older population of GS connected through emails, postcards and in-person gatherings.

In summary, Inreach programs and activities revolve around relationships and connections. They are aimed at felt needs and life-changing events in the lives of GS members.

The Refugee Ministry was initially born as an idea in the heart of a GS member, was nurtured in SAC meetings, and then became reality—and now has its own committee. We are thrilled that this vital new ministry has "taken off" at Good Shepherd. In 2022, SAC—together with other groups—brought God's Word, Our Hands Day to Good Shepherd. With many people currently struggling economically, Good Shepherd's Food Pantry is a valued and consistent source of support and so, by association, is the food pantry garden. SAC is blessed to now have both Pastor Dara and Rick Thomas providing ongoing guidance and support to our work. In 2023 and beyond, SAC will continue to focus on how we can share God's love with our neighbors, our community, and our world.


Strategic Planning Committee

Charter: The Good Shepherd Strategic Planning Committee assists the Church Board with its responsibilities for the church's mission, vision and strategic direction.



The Good Shepherd Board of Directors created the Strategic Planning Committee in April of 2021.

The final draft of the strategic plan was presented to and adopted by the Good Shepherd Board on June 13, 2022. The adopted Strategic Plan and the six pillars were presented to the congregation during the annual meeting on Sunday, June 20, 2022. The six pillars are as follows:

- Enhancing Welcome Experience
- Enhancing Worship Experience
- Enhancing External Community Connection
- Enhancing Internal Relationships
- Enhancing Spiritual Development
- Professional and Leadership Development

The Strategic Plan moved into the all-important Implementation phase. To successfully implement the plan each of the six pillars had a leadership team that consisted of: Committee Chair (from the committee most closely associated with the pillar objective), Board Member, Staff Member and Strategic Planning Committee Member. All of Pillar Leadership Teams met October 18 for an orientation gathering and to begin the advancing their pillar.

On April 24, 2023, all the pillar leadership teams met to share their progress and to hear from Eric Holmer about how pillar progress will be told via stories to the congregation.

Within the context of the Good Shepherd leadership structure of staff, board and committee structure: the pillar leadership teams have been meeting regularly to implement their pillar. Sara McCormack along with the church board is monitoring and encouraging each pillar's progress toward implementing the Strategic Plan and fulfilling the Vision and Mission of Good Shepherd.

Mission: In response to God's love and grace, the purpose of the Children, Youth and Family Committee is to:

- Teach that Good Shepherd is a place to feel welcome and safe
- Lay the foundation for what it means to live as a child of God and a disciple
- Support and connect children, youth and families from birth through all stages of family life

By the Numbers:

- 125 children registered for Church School; average attendance of 55 per week
- 95 middle schoolers participated in the Amped confirmation program
- Average of 25 high school students attending each youth group night

Staffing - Becca Feldhacker, former Youth Ministry Director, resigned her position and departed Good Shepherd in mid-May. Sarah Iverson has stepped back into this role on an interim basis, so that we can maintain consistency and stability for our youngest congregants. Because the social and emotional needs of young people have changed greatly since pre-Covid, the committee feels it is best to pause and take time for deep reflection before proceeding with re-staffing. The committee is taking the next few months to complete the following work:

- Review current staff structure and responsibilities
- Review research and current trends in youth ministry and structure from other congregations, with assistance from the Synod
- Review current programming and engagement
- Conduct family interviews and review feedback
- Craft recommendations for short term and long term staffing structure & programming

Spiritual Formation (cont'd)

Children, Youth and Family (Cont'd)

Children's Ministry - In addition to continuing baptisms, Church School and Vacation Bible School, there has been a renewed focus on Early Childhood Ministry. Emily Gold was hired as the part time Children's Ministry Assistant, and Emily and Joanne have successfully relaunched a 0-3 playgroup, created a new series of Friday night Family Dinners, and created a playground in the Madison sanctuary.

Middle School Ministry - A wonderful year of Amped concluded with 33 confirmands celebrating their Affirmation of Baptism in May. This group of eighth graders were highly prepared for this next step and showed tremendous growth and maturity in their approach towards their faith and their lives over their years in Amped. This summer will focus on Rise Up Nights for incoming sixth graders, Middle School Fun Nights and a focus on integration of the recent confirmands into high school ministry.

High School Ministry - Our high schoolers enjoyed their traditional fall retreat and hosted the return of the Chili Cook-Off and Pie Auction, a beloved intergenerational event that serves as a major fundraiser for high school activities. Summer 2022 saw over 20 youth travel to Kentucky for a week of community building, fellowship and faith walks. A similarly sized group will head to South Dakota in August. A new fundraiser, Christmas Camp, was held in December to support these trips. The high schoolers helped plan and lead a Friday night of fun for the children of the congregation, while the adults in their lives got to enjoy a night out for dinner and holiday shopping.

Facilities to Support the Mission - The Verona nursery has been repurposed as a lounge, with space for play, conversation and gathering for all generations. The space is a welcoming environment and hosts many wonderful parent conversations during Amped nights. Plans are in motion to complete the same repurposing of the nursery space at the Madison campus later this year.

Summary - CYF continues to work toward rebuilding connections lost during COVID. As we re-establish church activities into the rhythms of family life, we continue to see the fruits of focusing on nurturing relationships with the children, youth and families of Good Shepherd. The committee is committed to praying and dreaming about the future of these ministries, and developing the staff and structure to work towards that dream.

Spiritual Formation—Highlights

Summer 2022—We enjoyed many intergenerational gatherings out under our Verona tent – BINGO, a dance party, and an evening concert with Grammy-nominated musicians Gungor. These opportunities allowed for some wonderfully light moments. We often try to teach about grace and community and hospitality – but sometimes they are best learned by being experienced. These opportunities were just that. Places for our spirits to find a bit of rest, joy, and liberation, alongside others in the summer sun.

Fall 2022— We welcomed author Jeremi Suri in October. Jeremi spoke to us on his book “The Civil War By Other Means,” and initiated conversation among the multi-generational crowd about how we can make the world we’ve inherited a better place for our kids. A group of folks later gathered for a month of conversation on Jeremi’s book, bringing it into conversation with other texts and faith questions and commitments.

Tables of Eight returned after a Covid hiatus and has been a great opportunity for members, old and new, to meet other folks from the congregation they may not otherwise run into. Over 100 households have participated in this opportunity and the stories we hear from participants are wonderful as people find connection through their stories, meals, and the Holy Spirit. This was a great way to weave the web of GS community more deeply.

Winter 2023—In February we welcomed Dr. Drew Moser to lead a day-long program on the Enneagram. Over 50 GS members gathered to learn more about this ancient tool of knowing and discerning. It was a rich day of conversation that led to many connections within and between members. Later a group gathered for a month to read and discuss Dr. Moser’s book and continue our work together.

Eric Holmer, our director of communications and seminary student, along with Rick Thomas created a two month dinner and learning opportunity centered on The Chosen. For eight weeks, folks gathered to share a meal and watch and discuss this imaginative opening show. Other GS folks watched together on Wednesday evenings and many small groups and households watched on their own. It was a wonderfully layered experience of community. The show itself is a real opportunity for adults to once again start being imaginative with scripture, awaken the humanness of those we read about, and to consider the intimate knowing of Jesus with each of us.

We were once again able to offer a Lenten devotional created out of member stories. These devotionals are always a treasure, helping us to connect with one another and learning the many ways that God has worked in our lives. They become vehicles of liberations, connection, hope and knowledge.

Spiritual Formation (cont'd)

Spiritual Formation—Year Round

- We tried a new experiment bringing in a Theologian in Residence, Ryan Panzer. Ryan hosted five Conversation Sunday's from the pulpit, exploring various questions of faith. Alongside those conversation Ryan and Sarah Iverson worked to create supplemental materials to help expand the conversation, hosting small group conversations, creating resource questions for small groups, podcasts, blogs and more.
- Working alongside our Children and Youth staff we created a space for parents to be in conversation – formal and casual – while their middle school youth were at confirmation. Our new lounge space in Verona offered a beautiful space for parents to spend time talking about the challenges of parenting, as well as having conversations about their own faith journey and learning some new practices. We packed the lounge to its max the night we brought in Mary Birmingham, a school psychologist, to talk with parents about the joys and challenges of raising a middle schooler.
- Our Tuesday Trekkers continues to expand and thrive. This covid developed fellowship opportunity continues today, with anywhere from eight – 20 folks gathering every Tuesday morning to take a hike somewhere in the Madison area. This has proven healthy not only for our bodies but for our connections as well!
- Sarah Iverson also continues to create spiritual content and devotions for our Primetimers (weekly), and 20/30 group (monthly). She also continues to enjoy writing the blessings we send to our college kids, vocational groups, and life moments. She writes, shapes, and leads our Sunday evening worship service each week and participate in all the seasonal planning and connecting. Last September she stepped back into CYF ministries to supervise and create connections between our Children's Ministry, Youth Ministry, and other congregational ministries. This was a beautiful challenge, and she greatly enjoyed working alongside Joanne and Becca in this way. However with the departure of Becca to the Collaboration Project, she will now be stepping back into Youth Ministry full time. She continues to be excited by and challenged by this work and feels the church is at a point in our congregational growth, to really reshape this important ministry so we can continue to be leaders in how we nurture our young people in lives of faith.
- And of course alongside all of these programs and worship opportunities, I enjoy many one-on-one coffee conversations with members of all ages, learning their stories and offering a listening ear, occasional advice and always prayer.

In addition to organizing the annual spring and fall clean-ups of our grounds around the church buildings, the facility committee has helped to develop ideas and suggestions for other projects essential to maintaining church properties that are both functional and aesthetically pleasing. Some of the highlights of items that have been discussed and recommended over the past 18 months include the following: replacing the carpeting in the lobby and worship area at the Verona campus; the creation of a new gathering area and gender-neutral bathroom at the Verona campus; a new driveway and sign at the Verona campus; replacement and widening of the outside stairway in the parking lot at the Madison campus; removal and pruning of trees at the Madison campus; replacement of aging roofs at both campuses; and parking lot repairs and seal coating at both campuses.

Max Seeland has this to say about his time serving on the committee:

"I've enjoyed serving on the Facilities Committee the past couple of years because you can see the results of many of the recommendations to the Board, both inside and outside the building. I think we can all agree we have two beautiful campuses of which we can be proud."

All of the work that has been done over the past 18 months could not be done without all of your generous contributions to the church that enable us to continue to worship and serve others at our facilities. Thank you!

Charter: Build a stewardship ministry that provides for God as the owner of all, and we as the managers. Support members and non-members goals of living a financially responsible life that raises up Christ-centered stewards.

The "G-Force" continued the approach to Generosity begun under former chair Ronda Beggs during the formative 2021 annual campaign. While cultivating and growing our congregational support for the material and spiritual needs of our community, Generosity seeks to inculcate a year-round culture of abundance, rather than scarcity, in considering the life of our church. A church is not just another business in a capitalist economy, nor even just another nonprofit charity. Rather, we are a community defined by our faith in the God who promises abundant life and resources sufficient to the needs of the day, and the God who delivers on God's promises. Moving from strategy to tactics, Generosity looks to expand beyond one-season annual campaigns of asking for commitment of resources to year-round communication about all of Good Shepherd's activities and missions. These communications, whether a video during worship or an article on the website or in the email newsletter, serve as "deposits" of goodwill and interest with the people of Good Shepherd. Our annual generosity campaign amounts to a significant "withdrawal" of commitment from our people. Just as one cannot make a withdrawal from a bank account in which one has not previously placed deposits, so too does the potential success of our annual generosity campaign depend on the quality of deposits we make with our community throughout the year.

In fall 2022, Good Shepherd undertook both a regular annual generosity campaign and a special "Dreaming Beyond" capital campaign. Dreaming Beyond was intended as a campaign to pay down Good Shepherd's remaining mortgage debt over an 18-month timeframe. Both campaigns entailed a series of video announcements and website posts as well as individual and group outreach. Good Shepherd prioritized encouraging commitments to Dreaming Beyond above any strong push to increase annual giving commitments. Already, Dreaming Beyond income has enabled Good Shepherd to refinance our mortgage in a way that reduces monthly debt servicing costs and thereby frees up resources to serve our missions and ministries. Annual giving pledges held largely stable from 2021, which itself marked notable increase from 2020 pledge levels. As part of the joint Dreaming Beyond/annual campaigns, Generosity proposed that Good Shepherd hold a joint worship service at the Verona Area High School Performing Arts Center, which was followed by a luncheon to encourage participation in both campaigns. Following that service, Generosity team members joined members of several other Good Shepherd lay teams to engage in phone outreach to Good Shepherd community members who had not yet turned in statements of intent to give in 2023. Participating volunteers reported very positive experiences speaking with fellow Good Shepherd members about their interest in giving to our church in 2023. As a final step in the 2022 campaign, Generosity drafted a follow-up thank-you letter featuring stories about several vital Good Shepherd ministries that accompanied First Quarter giving statements distributed by postal mail.

Looking ahead, G-Force is working this summer to plan an ambitious 2023 annual campaign, with a tentative goal of increasing pledge commitments by 4.2%. We also anticipate a renewed capital campaign in 2024 as the giving period of Dreaming Beyond comes to a close. To meet these objectives this year and next, G-Force members look to expand the team by at least one or two new members, and to increase the visibility of the Generosity team through hosting video announcements, outreach events, and so forth.

Over the past year the Finance Committee continued to provide insight and direction to the Board of Directors regarding the short-term and long-term financial situation of the Church. Key activities include continued monitoring of the reserve levels at the Church, ensuring financial assets are safeguarded, and forecasting of future cash flows. We continuously monitor giving trends and report data back to the Board. Additionally, the Committee has convened with the Generosity Committee to brainstorm ideas for their upcoming campaign. At the end of 2022, Wade Huseth stepped down as the Treasurer. Tyler Gold, in his current capacity on the Good Shepherd Board, took over the role of Treasurer. In addition to that change, we added two additional members to the Committee, Adam Frey and Sara Ritter.



Mortgage Payment Reduction Plan

Thank you to the people of Good Shepherd Lutheran Church for your good and faithful service and for your continued financial support of the mission of our congregation. We are humbled by your generosity, as well as the call to be a part of the Dreaming Beyond capital campaign.

As of May 31, the total amount pledged to Dreaming Beyond is \$816,608. Of this total, \$393,227 (48%) has been received, with pledges receivable over the next 12 months totaling \$423,387 (52%). The commitment that all Dreaming Beyond gifts be used to reduce the mortgage has been honored, which has resulted in reducing the mortgage balance to \$690,440. At the end of the 18-months of the Dreaming Beyond campaign, the mortgage is projected to have a remaining balance of \$260,000.

While we did not reach our goal of eliminating the mortgage with this campaign, we know that the people of Good Shepherd will continue to express their generosity and we will be able to burn the mortgage soon. Call to Order

President Sara McCormack called the meeting to order at 12 p.m. It was determined that a quorum for voting on agenda items was met with both online and in-person numbers (FINAL count: 60 in person, 50 online- 110 total)

Opening Prayer

Pastor Chris Enstad, Lead Pastor, offered the opening prayer.

Approval of the Agenda

Stacy Nemeth moved to accept the agenda as written. Second by Steve Johnson. Motion carried.

Approval of Minutes from February 2022 Annual Meeting

Glenn Rindfleisch moved to accept the minutes as written. Brenda Wilcox seconded. Motion carried.

President's Report

Sara McCormack reviewed meeting content from the February 13, 2022 Congregational Meeting and reviewed other board and church accomplishments over the past six months. There was a task force created to update the Church Board Bylaws to align with the new plan for the fiscal year to end June 30. Moving forward we will continue to have congregational meetings in January/February and July/August to align with the budget and the fiscal year. The Bylaws Task Force document was approved in April and Sara thanked the committee for its work on that. Dave Vogt and Rick Blum spend numerous months adapting and revising the HR Employee Handbook. Thank you to them for their dedication and work on that document. After 15 months of committee work, the Strategic Plan is completed and was approved by the Board at their June 2022 meeting. This document is meant to be the "connective tissue" to bring us all together as a congregation. Sara also expressed gratitude for the Beyond committee and campaign as we are headed into the final phase of that campaign.

Elections:

Cathy Peercy motioned to disperse of written ballots for Board and Nominating Committee elections. Second by Tim Hughes. Motion carried. Vern Andren motion to accept the Board of Directors (Betsy Johnson, Tyler Gold, David Vogt). Second by Bill Wilcox. Motion carried. Dave Vogt made a motion to accept the candidates for the Nominating Committee. Second by Glen Rindfleisch. Motion carried.

Lead Pastor's Report

Pastor Chris Enstad thanked the congregation for doing the "business of the church together." Pr. Chris referenced Ezra Chapter 3 and talked about "us" and how our faith is not an independent endeavor. Our culture often tries to divide us, but even when we pray the Lord's Prayer we say "us." Our recent Strategic Plan had a committee focus on "us" and the strongest impact on our communities happens when we are being good stewards of all our gifts. Good Shepherd has announced to each other our intents on giving and with our best hopes and dreams these gifts can have. The budget being discussed and voted on today equals our plan on living out our hopes and dreams. The Strategic Plan plus the budget together are our spiritual "us" documents.

Strategic Plan Presentation

Steve Frei and Jen Holmer presented the Strategic Plan which was approved by the Board on June 20. Steve Frei gave an overview of the plan and stated how it is recognized how we are at a milestone and need to move forward with implementation of the plan. Throughout the process they asked many questions. There were 12 members on the committee and they met 18 times over 14 months to advance and create this plan. They outlined four steps they used:

Learning

Discernment – narrowed it down from 59 initiatives to six.

Creation of the Strategic Plan – including a summary that was presented to Leadership, a one-page synopsis and a description of each of the six initiatives.

Implementation – the plan is to assign one board member plus one strategic planning committee member plus one staff member to work with each of the committees to implement the plan.

Strategic Plan Presentation (cont'd)

Jen Holmer reviewed the six initiatives.

Enhancing the Welcome Experience: This impacts all of us. We want to make sure everyone is seen and welcomed at Good Shepherd.

Enhancing Worship: During each service we want to invite and welcome everyone to praise God. We want to continue to re-energize our services after COVID-19.

External: Community: We want to continue to show up in our two communities and reach and respond to the basic and spiritual needs of those communities. We want to equip all members to talk to others about Jesus.

Internal: Membership/Belonging: We have a goal to create pathways for members to create a closer connection to others and to God.

Enhancing Leadership Development: We want to live out our mission and vision. We want to invest in and develop leaders within our church.

Enhancing Spiritual Development: we want to create a "google" mapping experience for our Spiritual development.

There were no questions asked after the Strategic Plan presentation.

Welcome Video

Church member Andrew Chang was highlighted. He described his experience at Good Shepherd and how he was "welcomed".

2022-23 Budget Presentation

Wade Huseth made the budget presentation. He thanked the finance committee and especially Rick Blum and Diane Wenzel for going above and beyond. Our fiscal year ended June 30 and the last 12 months Good Shepherd was a solid year financially, especially compared to the plan. Little Blessings Preschool, with the help of some grants, came out ahead and had a successful year. During 2021, there was increased giving within the General Campaign. In-person attendance was up compared to the prior two years and there was an increase in weekly giving due to these numbers. Due to great leadership of our financial resources, we had \$41,000 less in spending.

Our mortgage is currently \$1.3 million. In January 2020 it was \$3.1 million. We have used \$28,000 in savings to fund operations and were \$137,000 ahead of budget for the year.

Our new budget asks for dreams and visions to be implemented. The FY 2023 proposed budget proposes more spending. Many proposals are one-time expenditures. \$145,000 is related to personnel additions needed to begin to implement the Strategic Plan. It has been approved by the Board to spend \$230,000 on roofs at both campuses. This is the right time given our financial situation and the costs of these projects will only continue to rise in the future. With \$145,000 in continued expenditures, in order to fund these things later, we will need more revenue. We need money. We can't live on our savings account. This will run out. If we want to continue to dream big, we want and need to do that from a stable financial position. We have a plan in place to constantly evaluate our safety net (three months of operating expenses on hand at all times.) **We will have 3.4 months in savings if the current budget is approved as a safety net.**

Questions from the congregation:

At our current rate, when will the mortgage be paid off? Answer: In 10 years, or in five years with a new capital campaign.

Have we considered solar panels for the Verona campus? Answer: No.

Is the increase in 3 staff people, or \$145k in the new budget? Answer: This is annual estimate.

Have staff raises been built in for the next fiscal year? Answer: Raises have been added in the past several months. We do not have another increase in the budget for this fiscal year. But the board continues to put thought into how we can make this an annual thing.

Do congregational numbers look good to sustain these increases in spending? Answer: With combined online and in-person attendance, our numbers are almost identical to pre-pandemic. Fiscally the numbers are about the same. It will be a function of generosity as to how soon we could pay off the mortgage.

Beyond Campaign Update

Bob Beggs offered an update on the Beyond Campaign. Almost three years ago in Fall of 2019 we made a collective promise/commitment for \$2,067,242 in pledges as a congregation. So far, we have received \$1,841,311 which is 89% of the total pledged. With these pledges the committee had promised 85% of that money to remit to Thrivent for debt improvement toward our mortgage. The other 15% was promised to the Capital fund. The committee has lived up to these promises and we are on track to end the Beyond campaign on track.

With money to the capital improvement reserve fund, the following has been spent –

\$63,000	on the Music Room in Verona
\$66,100	on digital improvements in Verona
\$93,664	Narthex in Verona
\$0	Air Handler in Madison

Bob Beggs, recognized Sara McCormack, the outgoing Board President, and thanked her for her dedicated service. She was instrumental in assisting the congregation in navigating through the Covid pandemic, starting and initially leading the Covid 19 Task Force, establishing and creating the Bylaws Task Force, assisting with implementation of the New Employee Handbook for church staff and played an integral part in the adoption of the Strategic Plan. The Good Shepherd Lutheran Church Foundation was established in 1987. The purpose of the foundation is to receive gifts, grants and bequests for the benefit of the Good Shepherd congregation. Although the foundation and the congregation are separate legal entities, the mission of the foundation is to expand and continue the legacy of the Good Shepherd congregation and to transform lives by reflecting the love of Jesus.

Since its creation, the foundation has become an important part of the Good Shepherd ministry by providing funding for programs that are not a part of the annual operating budget of the congregation. Gifts to the foundation become a lasting endowment as the funds are invested and the earnings are used to make grants to fund a variety of projects each year. As a general rule, the foundation spends 4.5% of its assets each year on those projects. At the end of 2022, the foundation's assets were approximately \$2.7 million, down approximately 16% from 2021 due to unrealized capital losses. The foundation received donations from congregation members in the amount of \$7,800 during 2022. Thrivent Financial serves as the foundation's investment adviser.

To further its mission to support the Good Shepherd congregation, the foundation distributed the following grants during 2022 totaling \$105,414.

The Good Shepherd Lutheran Church Columbarium, having been established in 2015, celebrated its eighth Anniversary in 2022.

The primary responsibility of the Columbarium Board is to perpetually maintain the final resting place for members and friends of Good Shepherd.

The last year we continued our focus on maintaining and ,where possible, enhancing the aesthetic appearance of the columbarium. The primary efforts in this regard were:

- Supporting Brad Nelson, long time member of Good Shepherd, as he volunteers his landscaping gifts and time to maintain the columbarium as we go forward. Thank you, Brad!
- Installing fresh mulch each spring and maintaining the water feature.
- Expanding the paver area to the west to enhance the phase two area.

All 72 of the original Phase One niches are sold and 17 of the 36 Phase Two niches are sold.

Little Blessings Preschool—Verona

Hello! My name is Linda Hayes, and I am the Director of Little Blessings Preschool (LBPS) at the Verona Campus of Good Shepherd. I am also the Lead Teacher of the Ravens class. I have worked at the preschool as a teacher since 2007 and as a site director in Verona since 2012 when our 4K program was started with the Verona School District. Since last October, I took on all director responsibilities at both the Madison and Verona campuses. In January of this year, Heidi Anderson assumed the director responsibilities at Madison campus allowing me to focus on our Verona programs.

Verona campus offers school-year preschool programming for ages 2 ½-5 consisting of a Verona School District 4K class and four private LBPS classes. We have five teachers in Verona: three lead teachers and two assistant teachers. Two of our teachers have DPI licenses. Our enrollment so far for the 2023-24 school year is:

- Verona 4K (T,W,Th,F): 19 children enrolled through the school district (two more will be placed this summer)
- Monday 4K: five children enrolled
- Whales (M,T): seven children enrolled (12 maximum)
- Ravens (W,Th,F): 17 children enrolled (16 maximum, I added one this year to accommodate siblings)
- Extended Day Classes (T,W,Th, 11:30-3): 15 children enrolled in one or more Extended classes. *The Extended Day enrollment usually increases once the school year starts.

Last summer an LBPS Committee was started and worked this year to support the preschool program. We meet once a month and members consist of a pastor, an administrator, the preschool directors, board and church members, and a preschool parent. The committee works collaboratively on the preschool's vision, supports LBPS in increasing our presence in the community, and provides support where needed.

The preschool utilizes Brightwheel, a childcare software, which allows us to efficiently communicate with families and have all student information readily available. A new development in December 2022 was to centralize all billing to allow families the capability of paying tuition directly through the Brightwheel app. Families welcomed this change and it made the billing process more efficient for both the families and the preschool directors.

This year, LBPS worked with the Verona School District to make the Verona campus a Pyramid Model site. The Pyramid Model promotes the social, emotional, and behavioral development of young children. We started the implementation process last August and attended a two-day training session. We continued throughout this school year to implement Pyramid Model through monthly meetings with our coach. The 4K classroom is now at fidelity, meaning they met all the requirements. The next step in the process is to do the same in the 3K classroom for the 2023-24 school year.

In conclusion, our goal for Verona campus is to continue our strong relationship with the Verona School District and our work with them in the Pyramid Model implementation process. We will also continue to utilize opportunities for training and development with the school district. We will continue to build strong relationships with children and families and offer a high-quality preschool program for the community.
